About the Opportunity:

We are looking for a Speech-Language Pathologist (SLP) to join our Therapy Services Team. Therapy services at the BC Centre for Ability include the Early Intervention Therapy program which provides physiotherapy, occupational therapy, speech-language pathology and social work services for over 1000 children and their families. Services are provided in the child's natural environments, as well as through clinic and group opportunities, and focus on helping the child become successful in their daily routines and participate in home and community life.

The successful candidate will work as part of an interdisciplinary team to provide therapy services to children within the context of their family and community environment. Services will be delivered in family homes, in clinic, in community settings and by virtual platforms. Departmental assignments are subject to operational and departmental needs.

A Day in the Life of a BC CFA SLP:

- Assess verbal and non-verbal communication skill development and the oral motor skills required for drinking and eating
- Provide support in the areas of language understanding and use, social communication, speech clarity, alternative or augmentative communication, fluency, pre-literacy skills and oral motor skills involved in eating and drinking
- Use a coaching approach with families and team members to educate and implement therapeutic programs based on family goals
- Use Evidence Based Practice and Family Centered Practice to guide decision making when developing goals and therapeutic programs.
- Maintain up to date records that meet agency and regulatory body requirements
- Collaborate with an interdisciplinary team and community partners.
- Participate in staff meetings, case reviews, medical liaison meetings, and in-services
- Maintain up to date records that meet agency and regulatory body requirements
- Undertake additional responsibilities as directed
